Some would say it has never been harder to wear the uniform. Celebrating great policing as a community has never been more important. Especially now, give exemplary acts the recognition they deserve. Did you know a recent study showed that a stunning 79% of employees surveyed felt undervalued, mainly due to a lack of personal performance recognition, and that it is this very recognition that keeps them engaged and motivated?

The CPOA Annual Awards Program has consistently recognized those acts and it is that time of year to again nominate individuals for that recognition. Selected individuals will be recognized at the **ADVANCE** Annual Awards Program ceremony at **ADVANCE** in San Diego on September 26, 2022.

Enclosed you will find the Awards Program categories and eligibility rules. We encourage you to look within your agencies for individuals to be recognized that fall within these awards categories. Especially pay attention to our newer 12 Under 12 category!

With the exception of the Certificate of Appreciation, nominated acts should have occurred between January 1 – December 31, 2021.

THE SHERMAN BLOCK MEMORIAL LAW ENFORCEMENT PROFESSIONAL OF THE YEAR AWARD

This award recognizes California law enforcement leaders who, like Sheriff Block, have distinguished themselves through a lifetime of dedicated service to their departments, their community, and to the law enforcement profession. With this award, CPOA selects to recognize a leader who exemplifies the Association's values and mission.

This individual is selected by the CPOA Board of Directors and is a featured presentation during the program.

12 UNDER 12

Purpose: This newer award category is designed to recognize 12 individuals (one from each of CPOA's 12 regions) with 12 or less years of service that exemplify the future of the law enforcement profession.

Eligibility:

1. Nominee may be sworn or civilian and must be currently employed by a federal, state, local, or tribal law enforcement agency.
2. Self-nominations are not permitted

Criteria for consideration:

1. Demonstration of values and commitment to law enforcement
2. Capacity for leadership
3. Nomination should include responses to the following questions:
 - Why are you nominating this person for this award?
 - Explain specific instances or examples (relevant accomplishments) that highlights your reason for nominating this person.
 - Attach Nominee's resume or CV

AWARD OF VALOR

Purpose: Recognition for extraordinary valor above and beyond the call of duty. Public safety officers must have exhibited extraordinary courage, decisiveness and presence of mind, and unusual swiftness of action, regardless of personal safety, in an attempt to save or protect human life. This award recognizes acts that demonstrate the nobility of the policing profession.

Eligibility:

1. Nominee may be sworn or civilian and must be currently employed by a federal, state, local, or tribal law enforcement agency
2. Nominations may be made by anyone, but must be approved by the nominee's head of agency.
3. Award is for a single act in the preceding calendar year (2021).
4. Recognition for extraordinary acts of valor above and beyond the call of duty.
 - Extraordinary is defined as going "beyond what is ordinary or usual; highly exceptional, remarkable."
 - Valor is defined as "courage and boldness, as in battle; bravery."
 - Where risk of life existed and nominee had sufficient time to evaluate it or where a reasonable person would assume their life was in great danger.
 - Where the objective is of sufficient importance to justify risk.

Criteria for consideration:

1. Demonstration of extraordinary professionalism as appropriate to his/her specialty through tactics, marksmanship or leadership; rescue skills; and/or medical knowledge or skill.
2. Demonstration of extraordinary character through courage, endurance or calm in the face of danger.
3. Nominee accomplished assigned mission:
 - suspect apprehended or killed
 - person rescued
 - life saved

*** When considering the nomination of a team (defined as two or more public safety officers responding to a single incident), there is no guarantee that all members will receive recognition. The actions of each team member nominated should be individually described, even though submitted as one nomination.**

AWARD OF DISTINCTION

Purpose: To recognize exceptional performance by an individual or departmental unit that goes beyond normal call of duty to enhance efficiency, public image, and provides a great service to the community. CPOA recognizes acts that serve as a model to its mission of Building Future Law Enforcement Leaders.

Eligibility:

1. Nominee may be sworn or civilian and must be currently employed by a federal, state, local, or tribal law enforcement agency
2. Nominations may be made by anyone, but must be approved for submittal by the nominee's head of agency.

Criteria for consideration:

1. There is no time limit on the service, but the program should be something that is unique, trend setting, and innovative. Ongoing program nominations should convey a significant revision to current program to the benefit of public safety.
2. Nomination should articulate results.

***When considering the nomination of a team (defined as two or more individuals), there is no guarantee that all members will receive recognition. The actions of each team member nominated should be individually described, even though submitted as one nomination.**

CERTIFICATE OF APPRECIATION

Purpose: To recognize an act, or acts, performed by a civilian (non law enforcement), business, or organization that supports, enhances, or assists the law enforcement profession.

Eligibility:

Any individual, business or organization that meets the above description.

Criteria for consideration:

Acts/service can be in areas of:

- Promoting through information and/or education channels the safety messages and goals of the Department.
- Assisting the Department in carrying out stated goals and responsibilities with direct assistance of time and/or funds.
- Coming to the aid of members of the Department through action and/or fundraising.
- Assistance and/or services which are deserving of recognition, but do not fall within the above examples.

NOMINATION PROCESS

1. Provide a complete description of the nominated acts in 2,000 words or less.
2. Log on to CPOA.org and complete the nomination form found under the "About" tab or mail the printed form found on the following pages to:
